III. CLASSIFICATION OF BUSINESS AND FEE SCHEDULE (Check One)

Class A – Businesses are exempt from the Business Permit Policy and are not required to register with the Pueblo or pay the Business Permit fee. The following are considered as Class A businesses:

1. Charitable, religious, community, educational organizations, or private individuals which engage in activity to raise funds for social, educational, religious or other purposes that are for the benefit of the Pueblo of Isleta or tribal community member(s).
2. Sellers of farming/agricultural produce that is solely cultivated on Pueblo lands.
3. Sellers of Indian oven bread and other traditional food products.
4. Occasional yard sales conducted at tribal member residences or properties, or conducted at a “flea market” business location where that owner has obtained a Business Permit for that type of activity.

Class B – Businesses Required to Register

Indian Arts and Crafts made or maintained for sale, whether wholesale and/or retail, by any Tribal Member..... No Fee

IV. PERMIT FEE PAYMENT

If application is approved, fees are to be paid in full. Once payment is made, submit payment receipt to Governor's Office and Business Permit will be issued. All payment are to be made at the Pueblo of Isleta Treasury Department located at 3590 State Highway 47, Building C-#119, Isleta, NM 87022.

V. BUSINESS PERMIT TERMS

By filing a Business Permit application with the Pueblo of Isleta, the Application agrees to the following:

- A. The applicant/permittee agrees to comply with all provisions of the Pueblo of Isleta Business Permit Policy and applicable Federal and Tribal Laws to ensure proper business practices, employees and customer safety, and environmental protection. Businesses are subject to periodic inspections by the Tribe.
- B. The applicant/permittee is responsible for the conduct of the business operation and the employees and agents of the business. The applicant/permittee shall no allow the sale or use of illegal drugs, intoxicating liquor or contrabands at the place of business.
- C. The applicant/permittee consents to the jurisdiction of the Tribe, including the Isleta Tribal Court, with regard to matters arising from the conduct of business and the Pueblo of Isleta Business Permit Policy.
- D. The business permit is non-transferable and is restricted solely to this type of business for which the permit is issued.
- E. All businesses are encouraged to employ Isleta Tribal Members and/or Native Americans.
- F. Applicant/Permittee shall maintain copies of inspection reports and other required records and take corrective actions to ensure compliance with the Pueblo of Isleta Business Permit Policy.
- G. The business permit shall expire at the end of ONE YEAR from the calendar year of issuance, unless issued for a shorter time period, i.e. daily, weekly, and monthly. Renewal of a business permit must be submitted at lease thirty (30) days prior to permit expiration date. Permit fees must be paid in full once the permit has been approved. No permit will be issued until full payment is received.
- H. The Pueblo of Isleta shall be held harmless of all claims and liabilities arising from the operation of the permitted business.
- I. Violation of the Business Permit Policy by the permittee shall be cause for suspension or termination of the business permit. No business is allowed to operate without a valid business permit.
